The goal of InFiNe.lu Scholarship Programme is to enable InFiNe.lu members to strengthen expertise in Luxembourg to advance financial inclusion.

InFiNe.lu offers 1 supplementary grant to employees from an InFiNe.lu member organisation to attend either the Boulder Microfinance Training (MFT), the Boulder Rural and Agricultural Finance Programme (RAFP) or the Boulder Digital Transformation (Digital). Note that the MFT and digital programmes are offered in both English and French. The RAFP is in English only.

The scholarship offered by InFiNe.lu covers the courses, coffee breaks, inaugural and graduation dinners and some extracurricular activities (USD 4,300 (in2019) for the English Programmes and USD 4,500 for the French Programmes). The cost of transportation (flight and other transport needed), housing, meals and activities shall be covered by the grantee.

1 The Boulder Programmes to choose from:

Programmes in English

1.1 The Boulder Microfinance Training (MFT in English)

July 20th-31st, 2020 - Turin, Italy

<u>The Boulder Microfinance Training (MFT) in English</u> is a 2-week programme targeting professionals working at every level of microfinance today (Microfinance Institutions, Support Organisations, Central Banks, Development Organisations, Investors, NGOs).

The programme offers a space to share ideas and strategies on how to face microfinance's issues and use new tools. The participants have the choice among several specialities (or "Concentrations") and numerous Elective Classes provided by microfinance experts coming from all around the world.

1.2 Rural and Agricultural Finance Programme (RAFP in English)

July 20th- 31st, 2020 - Turin, Italy

<u>The Rural and Agricultural Finance Programme (RAFP)</u> is a 2-week training programme for already experienced agricultural finance specialists bringing a global perspective on how to meet the financial needs of rural SMEs and agricultural households.

Beside Plenary Sessions, the participant will choose elective courses (1 in the morning, 1 in the afternoon, every week) among different options.

1.3 Boulder Digital Transformation of MFIs (DIGITAL in English)

July 20th-31st, 2020 - Turin, Italy

<u>The Boulder Digital in English</u> is a 2-week programme designed for microfinance managers and other financial inclusion professionals who were seeking effective strategies to digitise their institution or institutions they support.



Courses covers topics such as data management, business intelligence, product development, agile design, fraud, consumer protection, leadership, partnerships, regulation, and more.

1.4 Le Boulder Microfinance Training (MFT en français)

4 - 15 mai 2020 - Marseille, France

<u>Le Boulder MFT en français</u> est un programme de 2 semaines s'adressant aux professionnels du secteur (institutions de microfinance, banque centrale, consultant, investisseurs, ONGs ou encore organisations de développement).

Chaque journée est divisée en 3 blocs et comprend aussi des activités optionnelles offertes après les cours.

Le programme offre un espace de réflexion et de partage de stratégies et d'idées. Les participants pourront prendre jusqu'à 5 cours parmi les 8 offerts dans le programme en français.

1.5 Le programme Boulder de Transformation numérique des IMFs (DIGITAL en français)

4 – 15 mai 2020 - Marseille, France

<u>Le Boulder DIGITAL en français</u> est un programme de 2 semaines (70 heures de cours académiques) pour les directeurs des institutions de microfinance et autres professionnels de l'inclusion financière à la recherche de stratégies efficaces pour numériser leur institution ou les institutions qu'ils soutiennent.

Chaque journée est divisée en 3 blocs (Master Class commune avec le MFT chaque matin, et cours optionnels en matinée et les après-midis) et comprend aussi des activités optionnelles offertes après les cours.

2 InFiNe.lu scholarship applications

2.1 Eligibility criteria

InFiNe.lu scholarship is open to the following candidate:

- Employee working for an organisation member of InFiNe.lu at the time of the application and at the time of the training;
- Employee with knowledge in inclusive finance;
- Fluency in written and spoken in the chosen language (French or English) to attend the training.
- Not having received an InFiNe.lu scholarship in the past.



2.2 Guidelines to apply for the InFiNe.lu scholarship

The candidate must submit the 3 following documents in PDF format (in separate files):

- a Curriculum Vitæ of maximum 2 pages in English or French, depending on the training and the language choice when applicable (pdf document entitled Last Name_CV);
- a cover letter of max 2 pages in English or French, depending on the training language choice (pdf document entitled **Last Name_Cover letter**) demonstrating:
 - the link between her/his professional background and her/his participation to the chosen programme;
 - how the participation in the programme will be useful to his/her professional development
 - o her/his willingness and ability to represent InFiNe.lu network during the training.
- a letter of recommendation from the employer (pdf document entitled Last Name_Recommendation letter)

Applications must be submitted <u>no later than 17 March 2020, 04:00 PM CET by email</u> to: <u>contact@infine.lu</u>, with the email subject: **Boulder InFiNe.lu Scholarship Application 2020.**

Applications received after the deadline will not be considered!

2.3 Selection Process and Notification

- All applications will be reviewed by InFiNe.lu;
- A selection committee composed of representatives from InFiNe.lu members will select the successful candidate;
- Shortlisted applicant will be invited for a Skype or telephone interview with the selection committee;
- The successful candidate will be directly notified after the selection committee.

Important note:

- The InFiNe.lu scholarship is conditional to the final admission to the Boulder programmes.

3 Follow up of the Scholarship

The successful candidate will have to:

- publish articles about what she/he is learning on InFiNe.lu Website and social media during the programme;
- submit a max. 5 pages report about the training and present it to the InFiNe.lu board after her/his participation to the programme;
- make a presentation to InFiNe.lu members after her/his return.
